At 9:30 a.m. Public Comment

Tonia Maxwell, Allstate Insurance stated she is here to represent the local insurance agency and they would like to continue their working relationship with the county in suppling supplemental benefits. Ms. Maxwell did stated they do have some challengers with communication between the different departments. Ms. Maxwell did state that contacting the individual departments themselves is working better than relying on Human Resources.

Other Business

Mr. Bauer explained that the sign is still not up. Mr. Bauer did contact Mr. Fredrick to see what the delay is. Mr. Bauer also stated that Mr. Tkach wanted to go to Pepperidge Farm to get cookies for the open house. Ms. Hazel is against this, because she doesn't want half of a cookie. Mr. Bauer stated that they have agreed on the time for the open house to be 2 p.m. – 5 p.m. The sign was to be placed by Thursday, August 13, 2015. It's being delayed Studer-Obringer needs to dig the footer and Richland Engineering has to be inspected, which will be a (1) day delay.

At 9:44 a.m. the board recessed.

At 9:58 a.m. regular session resumed.

Valerie Swarts-Hoy Colonial Insurance came before the board to present report on the county's supplemental insurance. Charles Hoy explained that they spoke to Beth, Huron County Payroll in regards to what we have in place now, we currently have 401 full-time employees, with 24 Allstate Universal Life and 35 Allstate accident. Mr. Hoy explained that 22 short term disabilities through AFLAC and 15 accident along with 10 cancer policies. Mr. Hoy explained the disability insurance, common illnesses or health conditions make up 90% of paid disability claims, it's not that we don't have good health insurance, it's just health insurance only covers so much. Mr. Hoy stated that they offer financial

protection including home health care needs, travel and lodging, rehabilitation and child care.

Mr. Dunlap stated to Mr. Hoy that they were going to come back and let the county know where they may have gaps at with AFLAC and Allstate, because during this report he did not deliver. Ms. Bommer explained that AFLAC does offer all the items that Mr. Hoy presented in his report. Ms. Bommer explained Allstate has been limited by the county with two types of insurance, they can step in an offer the other items as well. Ms. Bommer explained that the objection was not with the products they offer it was that the county already have two providers that are offering voluntary insurance. Ms. Bommer stated she thought they were going to have a comparison with the current plans the county has to help save the employees money. Ms. Hoy explained that there are holes in their plans, the county currently has 24 people in a pool of 401 why is that? Ms. Hoy stated they don't enough information on the counties current program to make a fair comparison. Ms. Hoy explained that the wellness benefit is also built in to the plans. Ms. Hoy stated they really like to push the lunch and learn events, they work around the employees schedules including 2nd and 3rd shift.

Mr. Dunlap stated that he is fine with what the county has, he doesn't want to confuse the employees. Ms. Bommer stated that the cost is the big reason for the lack of participants.

Tonia Maxwell, Allstate asked if the Commissioners had any questions in regards to what Allstate offers. Ms. Bommer stated that Allstate is only aloud to offer (2) policies. Mr. Bauer stated that the fact that Allstate is local is helpful, where Colonial is out of Dublin, Ohio.

Cheryl Nolan stated that the CHIP partnership grant with the City of Norwalk was awarded, we will be receiving a letter very soon.

At 10:27 a.m. Joe Hintz moved to adjourn. Gary W. Bauer seconded the motion. The meeting stood adjourned.
