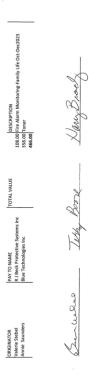

At 9:05 a.m. Public comment - *Pete Welch, Director of Operations*. Mr. Welch said this coming Monday, April 8, Rumpke is going to shut down their facility at 1:00 for the eclipse. Everything he sends out will have to be there by 1:00. Mr. Welch was recommending they shut down the transfer station as well. Mr. Boose suggested they close at noon. He thought it would be a good idea to get a sign up as soon as possible.

Mr. Welch asked if they planned to change how they were doing the floor in the Veterans area. He would have to change the bid specs if they do. Mr. Brady said he had been out there yesterday for the meeting. Because of the all the wheelchairs, service dogs, and other issues, they would like to have a hard surface in there. Mr. Brady mentioned this to Mr. Welch this morning and he suggested maybe something like the epoxy floor they put downstairs. That would last a lot longer than vinyl plank. Mr. Welch said he has done the bid specs and Mr. Strickler has reviewed them. Right now they have carpet going in there. He needs to know if they are going to change that. Mr. Boose was not in favor of doing anything other than carpet. Mr. Wilde did not know how many service dogs they get. But wheelchairs can roll on carpet. Mr. Boose said Job & Family Services has wheelchairs come in all the time. Mr. Welch noted that carpet was the most affordable. The whole building will be the same. This way in the future if things get moved around everything will match. Mr. Boose said Job & Family Services is always moving things around out there. Right now they are moving Ohio Means Jobs to the front. He said if he thought the carpet was going to get damaged he wouldn't do it. Mr. Wilde pointed out if there is a bad situation you can clean it or replace the

carpet squares. Mr. Boose thought the area would be a lot harder to pour. Mr. Welch agreed, saying they would have to empty the space out completely to pour it. Mr. Brady didn't think vinyl plank would hold up like carpet when you run wheelchairs over it. Mr. Welch was hoping they would be able to go out to bid for the carpet next week. Mr. Boose asked if they bid it per square foot, or for the total job. Mr. Welch says he has it set up for the total job. Mr. Boose noted it says approximately 36,000 square feet. Mr. Welch said he has to reduce that too. Mr. Boose asked, if we say approximately 36,000 and it comes up to be 36,500, who is responsible for the measurements? Mr. Welch said he has language in the bid documents that allows them to take their own measurements and figure out the quantities. Most carpet companies will do their own measurements because they have to figure out how much overstock they will need. Mr. Boose asked how we get extra squares in case we need to replace them. He asked if that was anywhere in the bid. Mr. Welch thought they bought additional boxes from the contractor after the job was finished when they did it before. The carpet they have used and the carpet they are going to use has always been available. It is a pretty common, standard carpet. Mr. Boose suggested he may want to discuss it with the contractor and ask them to order a certain amount over what is needed. That way we should get the best price. Mr. Tansey suggested just adding a line item in the contract. Mr. Boose was concerned that at some time in the future they would change the carpet. They don't keep the same carpet forever.

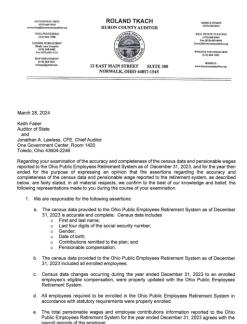

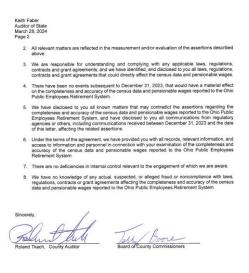

Mr. Boose asked Mr. Tansey and Mr. Strickler about a complaint he received last week regarding the use of commercial trucks on county and township roads. This person was okay with agricultural, and understood if you have a business and need to get trucks back and forth. Mr. Tansey stated that, unless the road was restricted due to weight restrictions, if it is a legal Ohio load they have the right to be on the road. You can't pick and choose who you want to use it. Mr. Boose asked if commercial drivers have the same authority as everyone else. Mr. Tansey said his office would prefer they stay on the state routes that are better equipped to handle it, but there is nothing that can be done to prevent it if it is a legal Ohio load. They get various complaints throughout the year but you can't tell someone they can't go down the road just because you don't like the size of their vehicle. Discussion followed regarding portable scales and the fact the locals are more likely to be overloaded than businesses.

Mr. Tansey stated he submitted his annual report. It summarized everything they had done last year and had a 2024 project list.

Commissioner Wilde report

Board of DD breakfast last week.

They attended Chris Mushett's retirement party last week.

Land Bank application has been sent in. Mr. Boose had been looking at aerial pictures of the area. He wondered if the area they thought was an orchard was where the ditch is that is full of trees. It's in the same area. Mr. Boose asked what the chance was that we would get demolition money this year. Mr. Wilde said none, it is for 2025. Mr. Boose asked what it depended on for 2025? Mr. Wilde said they sent in three projects for Brownfield. From what he understands we either get it or we don't. Mr. Boose asked if Brownfield included demolition. Mr. Brady said one fund is for remediation of underground issues, which is the Brownfield. However, he thought he said we could get demo money out of the Brownfield account. Mr. Wilde said they demoed E. Main Street with Brownfield. Mr. Boose would like to get something official from the Land Bank that yes, this money is going to be used by the commissioners. Mr. Brady said they really can't do much until they do the test. Mr. Boose thought it was hard to budget \$1 million not knowing if you were going to need it all. You can do a lot of projects with an extra \$500,000. Ms. Ziemba asked if they had reviewed the proposal sent by MakSolve. Everyone had read it. Mr. Strickler said it was fine.

Thursday at 3:00 is Family Dependency Court graduation.

Donate Life flag raising Friday at 9:30 a.m. at Norwalk City Hall.

Mr. Boose said there was going to be a presentation on Thursday. It is a significant project with significant dollars. It is called Mobile Crisis program. The money is going to have to come soon; it could be as high as over \$400,000. Mr. Wilde noted he had that presentation yesterday at Rotary. Mr. Boose said the question comes, where is the money going to come from, and who writes the checks. He was not sure the commissioners want to take on another project and write checks. But, on the other hand, if we don't come up with the money then it's not going to happen. Mr. Boose asked if that was portrayed yesterday at Rotary. Mr. Wilde said it was not. Mr. Boose explained they could cut it back to \$300,000+ by cutting back on hours of service. He said the other side of it is, the first year it is an extra \$90,000 – \$100,000 to get it up and going. After the first year the price goes down about \$90,000/year. So, this will be an annual thing.

Commissioner Brady report

WAEDC meeting tomorrow. Willard Area Economic Development Council.

Veterans meeting yesterday. Ms. Ziemba and Mr. Stephens also attended. Discussed concerns about compensation line item. Mr. Boose noted that Ms. Ziemba disagreed with some of those items. She indicated that is not how the rest of the county does it. Mr. Boose suggested the next meeting they have should include the auditor's office. Mr. Brady said Ms. Ziemba had to leave for another meeting, so he has not had a chance to talk to her. Mr. Stephens filled the Veterans in on the ORC requirements and how things work. They definitely want to work with the commissioners and do things how they are supposed to be done. Mr. Brady thought it was a good start and will discuss the meeting with Ms. Ziemba.

Yesterday Mr. Brady attended the interview Norwalk Ohio News did with Mr. Mead. They talked about the SCBA bottles we received. This is equipment for when firefighters go into hazardous areas that don't have enough oxygen. Four will be in the hazmat trailer up here; four will be in the hazmat trailer in Willard; one will be with Mr. Mead so he has one at all times. Mr. Gillmor was there with the drones. The sniffer

is very little and attaches to the drone. Mr. Gillmor sent Mr. Brady a lot of the pictures of the Senior Center. The clarity of the pictures was incredible. Mr. Gillmor had to get special permission because the jail is a "no fly" area. It is geofenced, so if you try to fly the drone over it, it just hits the "fence".

Mr. Boose said that Ms. Ziemba mentioned yesterday that the airport has 26 or 27 planes coming in. He asked how many tie downs they have. Mr. Brady said if they aren't staying overnight they don't have to be tied down, they can just tarp. Mr. Boose asked if they were just coming in for the day. Ms. Ziemba said it doesn't say one way or the other; it just says "just to confirm that we have 27 planes scheduled to come in for the next weekend". Mr. Brady said because of that they are regulating slots for takeoff to keep things orderly. He wasn't sure how many tie downs were out there, but he was pretty sure they didn't have 27.

Mr. Boose said he went down Laylin Road and saw a whole row of trees down by the airport. He asked if that was Storage Masters. Mr. Brady said it was. They cut down the scrub trees and are clearing it out before giving it to the county, if we take it. On the east side of the road there was a tree line that had a lot of trees on the airport side. Tom Shaffer owns the property, so he took down trees on his own. The airport may reimburse him some money for fuel. Mr. Brady was hoping this would leave enough grant money for the airport to take down the trees that had been taken down once but had regrown.

Mr. Brady will be at Family Children First Council tomorrow morning.

Friday is the annual meeting for CEBCO so Mr. Brady will be in Columbus.

Commissioner Boose report

Mr. Boose mentioned the Armstrong NASA event. He thought the speaker was very interesting.

Workforce Development meeting yesterday. Discussed Black & Decker layoffs; JFS set up a Job Fair right away.

Met with architect yesterday regarding Senior Center. Discussed the sign. Mr. Tkach had indicated that the state may be changing the logo. Mr. Boose said they need to get the sign ordered and installed. The old sign is going to be moved over to the east entrance. They need to know if the one on the west entrance is only going to be for Enrichment Services. Mr. Boose thought someone from the commissioners' office should send a note to the clerk and the auditor that we need to know. He noted they are both invited to these meetings but have not come to any. Mr. Boose thought a change order would be necessary to move the one over to the east side. That one is not illuminated, but the new one will be. He was pretty sure there was conduit all the way from the breaker box to the sign location. But there is no wire run. The electric company was part of the meeting yesterday, they were willing to figure it out and get it done ahead of placement. But there will be some additional charges. There is no base to where they are moving it. The architect is going to figure that out. Mr. Boose mentioned that there are two pieces of equipment Mr. Beal wanted to move from their kitchen to the new kitchen. But timing is everything. Once it is moved they can't use it; they will have to do cold meals or use Willard.

Tomorrow morning Mr. Boose has the meeting about the Mobile Crisis program.

Firelands Forward meeting at 8:30 a.m.

At 10:00 there is a RUMA meeting.

Mr. Boose said there is a letter they received from the state that explains how to apply for the money that is set aside. They note that there is only \$1 million. So what we get reimbursed for is not going to be 100%. He wanted to bet that Cuyahoga County could apply for \$1 million for themselves. But we need to encourage everybody to apply for as much as they can. Ms. Ziemba confirmed he was talking about the eclipse reimbursement.

CCAO bulletin lists information on a new bill being introduced that will allow Land Reutilization Corporations, also known as Land Banks, to be considered financial institutions from which townships could borrow funds. Mr. Brady said they had a presentation at the last meeting by a company, Blue Door Development. It consisted of three different entities - a developer, a builder, and a financier. They work with the Land Banks, and particularly have been working with the Richland County Land Bank. They acquire properties and then build duplexes and triplexes that they continue to own and rent out. Their rent if very reasonable; they keep it in line with Metro. They are interested in working with the Huron County Land Bank on properties that may be available where they can go in and build housing. Mr. Boose asked if anybody was going to the 13th annual Land Bank Conference. Mr. Wilde said that Mr. Pickworth, Mr. Loughton, Ms. Lykins and Ms. Ross planned to attend.

Mr. Boose said there was a grant called Nature Works Grant program. This provides reimbursement assistance for local governments to acquire, develop or rehabilitate recreational areas. Funding available is \$150,000 per county. Mr. Boose had a lot of questions: Who was entitled to that money? Who decides where this money goes? Should the county park district be looking at this? When we get ready to clean out the ditch at Shady Lane, could this help pay for that? Ms. Ziemba looked up the information on the grant. She read "Eligible applicants are city conservancy districts, county local governments, park recreational district, township, villages. Nature Works projects are funded through the Ohio Parks and Natural Resource Bond issue, which was approved by Ohio voters in November 1993. It is a 75% reimbursement assistance for local government subdivisions for the acquisition, development and rehabilitation of recreational areas". Mr. Boose asked who decides. Ms. Ziemba said Department of Natural Resources decides. Someone from Huron County has been awarded it every year. She listed: City of Norwalk for the Norwalk Reservoir playground replacement at Veterans Memorial Lake park; Willard received it to construct a dog park with two separate fenced areas; Wakeman received it for the Red Cap. In one year New London received money for improvements to the beach pavilion and City of Norwalk received it for the Family Parks paved perimeter trail. So more than one entity can receive at one time; granted neither one of these was very much. \$33,000 for the City of Norwalk; \$4,000 for New London. The other ones were \$12,000 each. Mr. Boose thought when Greg Telecky comes in we ask him to start with this project if we agree to go forward with them.

Mr. Boose said County Current asked us to make a call for advocacy to retain jail funding in the senate. If you read the article, as it currently stands if your county is within the ranks of 1-40 or a large county jail then you could get some of this money. We are not. Mr. Boose was not sure why this came out in Counties Current. At their last board meeting he was pretty sure they voted to opposed the way that the funding is going because they don't think that is a fair way to do it. There was an article yesterday regarding Cuyahoga County going for jail money. The land they want to buy is \$33 million. Their jail is going to be in the nine digits.

Mr. Boose does not understand another new bill that would create an exemption to the requirement that candidates must provide all names used in the past five years. Why would you do that exemption? If somebody is changing their name you want to know that.

Mr. Boose said this was National County Government month. For that, CCAO has put together a packet for us. One of them was two signs. He asked Mr. Minor to put those outside. Some of the items they provided were customizable. If you look at the information in the Ohio Counties Matter, there is a really good explanation of what county government does. Mr. Boose thought a lot of the information could be very helpful if someone were to teach a class. Ms. Ziemba said we had done a bunch of brochures last year. Mr. Wilde has Project Leadership on April 11. He would love to pass them out.

At 11:15 a.m. Bruce Wilde moved to enter into Executive Session ORC 121.22 (G)(1) to consider the appointment, employment, dismissal, discipline, promotion, demotion, or <u>compensation</u> of a public employee or official, or the investigation of charges or complaints against a public employee, official, licensee, or regulated individual and ORC 121.22 (G) (4) preparation for, conducting, or reviewing negotiations or bargaining sessions for public employees, concerning employee compensation or other terms and conditions of employment. Harry Brady seconded the motion. The roll being called upon its adoption, the vote resulted as follows:

Commissioner Boose report continued

Mr. Boose mentioned the Health Department gave a presentation at their annual meeting a couple weeks ago. They wanted to inform the committee that they have boxes that go outside of buildings to put Narcan in for the public. Anybody that needs Narcan can take it out of the boxes. Mr. Boose thought that might be a good idea for the county buildings. He asked Mr. Hollinger if he had given all the boxes away; we don't want to take them away from anybody that wants them. Mr. Hollinger indicated very few people have requested them. The county can probably have as many as they want. Mr. Hollinger asked that we let the

media know so the community knows they are available to private industry or anybody that wants them. Mr. Wilde said MHAS did a presentation at Rotary yesterday. He specifically had them talk about the boxes so there are some business owners who understand they are available. Mr. Boose said we need to let Mr. Hollinger know how many we want. His original thought was it would be nice to have one at the Administration Building, although he did not know where they would put it. The better place is the back of the building, but they said they prefer to have them covered and out of the sun. Mr. Boose thought one here, one at the Office Building, and maybe one at Job & Family Services. Ms. Minor originally said no, but that was when she thought we were talking about the vending machines. She asked for some time to think about it, but she thought it would probably be okay to put one there. Mr. Brady thought it was a good idea. He asked if they needed a motion or a resolution to do it. Mr. Boose suggested they think about it for a week. When they officially ask Mr. Hollinger he would love to do it by motion or resolution, something for the media. Mr. Strickler thought if they were going to do it on multiple buildings they were better off to do a resolution. Even though he was pretty sure it was not legally necessary. He just thought it might be better to do it that way. Mr. Boose thought Ms. Ziemba might want to get the official name of the project from the Health Department.

At 11:51 a.m. Terry Boose moved to adjourn. Bruce Wilde seconded the motion. The meeting stood adjourned.
