The Huron County Auditor presented a report on the county revenue and budget at the April 1, 2008 Commissioners' board meeting. The report stated that the revenue is down 9%, expenditures up 1%, and cash flow down \$618,335 or 27%. Along with this the sales tax is down 2.50% for the first quarter which is in the amount of \$48,886.

To that end we do not intend to approve the hiring of two (2) permanent part time employees for the Board of Elections staff and do not intend to appropriate the reimbursement from the Secretary of State to the Board of Elections budget in the amount of \$46,435.58. Furthermore the Board of Elections was informed at the interim and final budget processes of the tight budget situation and that no additional money would

be budgeted for 2008 request of additional employees. Please adhere to the final budget appropriations.

The reimbursement of expenses for the November 6, 2007 and December 11, 2007 special elections will be returned to the contingencies fund.

Dear Mr. Burton:

On April 1, 2008, a hearing was held at the Commissioners' Office at 180 Milan Avenue to review allegations that the County Dodge vehicle used for snow plowing was found on one occasion to be without brake fluid and on another occasion to be three quarts low on oil. You were given copies of employee statements from Jeff Deeble and Royal Chisholm and provided with an opportunity to give testimony regarding these statements. In attendance were Commissioners Gary Bauer and Ralph Fegley, Administrator/Clerk Cheryl Nolan, Assistant Prosecutor Daivia Kasper, Director of Human Resources Sue Bommer, you, and Sheriff Richard Sutherland, your designated employee representative.

Following presentation of testimony and ensuing discussion, the general consensus was that clear policy was needed regarding maintenance responsibilities for the operation and care of all Huron County vehicles and that such policy would be drafted as soon as possible. While we acknowledged that a regular maintenance schedule needed to be established and followed by you, we also allow that individual drivers of vehicles are responsible for checking vehicle fluid levels and reporting to you promptly any indication of a problem with any vehicle.

By your own testimony, you admitted that fluid levels (i.e. oil, transmission, brake, etc.) on the above-named vehicle, which, it should be noted, is housed in your garage and for which you are the assigned mechanic, had not been checked by you since September 10, 2007. This is another example of unsatisfactory work or failure to maintain a required standard of performance for which you were given documented verbal instruction and cautioning on March 13, 2008. This letter, therefore, constitutes a written warning for a second Group One offense (see Huron County Personnel Policy Manual, Section 10.2, Progressive Discipline). This written disciplinary action will remain active in your personnel file and counted in the progressive scheme of discipline for twenty-four (24) months provided no other offenses of the same or similar nature occur (see Section 10.2 above, G and H for complete details).

We hope to continue to work together to ensure the safe and cost efficient operation of all Huron County vehicles. Thank you for your cooperation.

<u>At 10:00 a.m.</u> Ginny Shrimplin, CORSA, Mike Meinke, Kim Bache, Bache & Associates, came before the board in regards to the CORSA renewal for the 5/1/08 - 4/30/09 program year. Ms. Shrimplin explained the changes in insurance carriers and talked about the loss fund.

A discussion was had in regards to the bond fund equity, and Ms. Shrimplin stated that the CORSA board decided to do this return over a 4 year period and are in the third year of this period. Next year will be the last year. Ms. Shrimplin explained that the cost for coverage is up 4.9% this year and further discussed the loss fund experience.

Ms. Shrimplin stated that CORSA would like to set a training session for Elected Officials, and Dept

Heads, to help elevate some of the loss experience.

Ralph Fegley reported on attending the Area 7 meeting and reviewed his notes from this meeting.
