Re: H.B. 694 – "Pay to Play" Legislation

Honorable Sue Morano; Honorable Matthew Barrett:

Since April 4, 2007, Huron County has joined others across Ohio that are attempting to abide by the regulations set forth in H.B. 694, adopted by last year's General Assembly. With no time to prepare for this, or educate those who are responsible for the administration of the legislation, we are struggling to understand and comply with the requirements, as are our vendors.

We have learned that State Representative Dan Stewart has filed legislation, H.B. 221, to remove sections of H.B. 694 from the Ohio Revised Code. We strongly support this effort, either to delete the bill or rework the legislation to make it more practical and logical. The paperwork is cumbersome, and the language is difficult to understand. In addition, we believe that many portions of this bill are unnecessary.

We ask that you join Rep. Stewart in addressing this badly-written legislation. It appears that local governments are now paying the price for problems at the State level. With nearly every county in Ohio facing tight budgets and reduced staffing, it is difficult to comply with this mandate and the excessive bureaucracy it has created.

Please let us know if there is any way we can assist in the effort to revise or eliminate this bill. Thank you in advance for your consideration in resolving this issue.
